1.0 <u>Instructions to Tenders</u>

- Tenders are invited in two bid system:(i) Techno-Commercial Bid (ii) Price Bid. The 1.1 'Techno-commercial Bid' will be made and put in the first envelope containing the title 'Techno-commercial Bid' it should contain full information as required in Annexure - I. The 'Price Bid' will be made and put in the second envelope containing the title 'Price Bid'. It could include full information as required in Annexure - II. Both bids should be put in the third envelope which should be prominently superscribed as "TENDERS FOR PROVIDING COMPUTER EDUCATION SERVICES" and addressed to "The Principal, Jawahar Vidya Mandir, Shyamali colony, Ranchi -834002" on or before 15/02/2021 till 12.30 PM. The tenders will be opened on the same date at 1.00 PM on 15/02/2021
- Tenders received after due date and time mentioned above, as well as those received 1.2 without separate sealed envelopes as specified above will not be accepted.
- It may be noted that conditional tenders or tenders incomplete in any respect will 1.3 not be accepted.

2.0 **Eligibility Criteria**

- The bidder should have experience in the last five years from the date of tender for 2.1 imparting computer education services in minimum of 3 schools, including 1 (one) school from Ranchi.
- The bidder should have at least ten (10) numbers of IT Professionals (minimum 2.2 Bachelor in Computer Application/ Graduate with One year Diploma in Computer Application) on Permanent rolls of the company.

5.0 PERIOD OF CONTRACT

The Period of contract shall be for three years (Academic session) from the date of commencement of the contract. Each year the performance of the bidder will be reviewed and, if the bidder does not provide satisfactory services that would have been intimated or recorded or for any other reason deemed necessary by the school, the contract can be terminated at any time with a prior notice of 30 days.

On expiry of the contract after 3 years, either the contract may be extended on yearly basis two more times with the mutually agreed terms and conditions according to the performance of the agency or may go for open tender.

6.0 SCOPE OF WORK

- 6.1 Providing computer education to all students of classes IV to X at JVM, Shyamali, Ranchi.
- 6.2 Design the syllabus and course according to CBSE norms.
- 6.3 To depute minimum Four (4) regular computer faculties.
- 6.4 The faculties should follow the school timing and provide technical support to the school.
- 6.5 Setup and maintain computer lab with hardware and software with minimum of 30 Computers having minimum core i3 with 4 GB RAM and one (1) Projector
- 6.6 Conduct exams and handover the results to school and update the result in ERP.
- 6.7 Arrange facilities required to conduct Online Classes for their faculties.

7.1 Final Evaluation

Final evaluation would be done using Quality and Cost Based Selection (QCBS). An overall score will be calculated based on the Technical Score 60% and Financial score 40% based on the following method.

TS= Technical Score

F1 = Fee quoted for Class IV to VI

F2 = Fee quoted for Class VII to X

BF = Average Fee of (F1, F2)

LAF = Lowest Average Fee Quoted among the Bids

FS = Financial Score = (LAF/BF) * 100

OS = Overall Score = (TS *0.60) + (FS*0.40)

8.0 Terms and Conditions

- 8.1 The School will provide Class rooms and Electrical power only.
- 8.2 Regularly conduction of Theory and Practical classes.
- 8.3 Faculties will explicitly follow the rules and regulation of the school in conducting tests and awarding marks/grades to the students.
- 8.4 The faculty will report to the school as per school timing.
- 8.5 Bidders should be responsible for the maintenance of the computers supplied and should ensure 100% uptime of system.
- 8.6 Bidders should get approval of the syllabus/courses from the school before the commencement of the session.
- 8.7 To depute minimum Four (4) regular computer faculties.
- 8.8 Bidders should arrange alternate teacher in case of leave.

9.0 Performance Guarantee (Security Deposit)

The successful bidder shall give performance security in the form of Account Payee Demand Draft from a Commercial Bank amounting to Rs. 25,000 (Rupees Twenty-five Thousand only) in favour of "Jawahar Vidya Mandir". The Security Deposit will be refunded only after the expiry of the contract.
