Sealed tenders are invited for award of Supply, Installation and Commissioning of CCTV System at Jawahar Vidya Mandir, Shyamali, Ranchi as per the Technical Specification attached as Annexure – I from registered, reputed, experienced and eligible firms who have executed similar nature of work in Schools/ Institutions/Organizations and satisfying all the terms and conditions in this tender document.

1.0 Instructions to Tenderers

- 1.1 Tenderer's are advised to visit the site before quoting for the tender.
- 1.2 The detailed technical specification and Bill of Quantity (BOQ) is given in Annexure I. Any other items not specifically mentioned in the specification but which are required for complete erection, testing and commissioning, safe and efficient operation and performance of the CCTV System are deemed to be included in the scope of the Tenderer unless specifically excluded without any extra cost.
- Tenders are invited in two bid system (i) Techno-commercial Bid & (ii) Price Bid. The 'Techno-commercial Bid' will be made and put in the first envelope containing the title 'Techno-commercial Bid'. It should contain full information as required in Annexure II & III and documents mentioned in eligibility criteria 2.0. The 'Price Bid' will be made and put in the second envelope containing the title 'Price Bid'. It could include full information as required in Annexure IV. Both bids should be put in the third envelope which should be prominently super-scribed as "Tender for Supply, Installation and Commissioning of CCTV System at Jawahar Vidya Mandir, Shyamali, Ranchi." and addressed to "The Principal, Jawahar Vidya Mandir, Shyamali colony, Ranchi 834002" on or before 21.02.2019 till 1.00 PM. The tenders will be opened on the same date at 2.30 PM on 21.02.2019.
- 1.4 Tenders received after due date and time mentioned above, as well as those received without separate sealed envelopes as specified above will not be accepted.
- 1.5 It may be noted that incomplete in any respect or conditional tender will not be accepted.

2.0 Eligibility Criteria

- 2.1 The Bidder shall submit LOI/Order Copy of
- a) Three similar completed works costing not less than the amount equal to Rs 12, 00,000/- or
- b) Two similar completed works costing not less than the amount equal to Rs 15, 00,000/-.
- c) One similar completed work costing not less than the amount equal to Rs 24, 00,000/- of the estimated cost.

- 2.2 The Video Surveillance server, IP cameras must be from same OEM.
- 2.3 Bidder must submit specific Authorization letter from OEMs of all products eg: IP camera / Server / PoE switches.
- 2.4 The entire setup will be maintained by bidder for a period of 3 years from the date of acceptance (The bidder is required to maintain sufficient spares and manpower at site to ensure 99% uptime).
- 2.5 Bidder must be registered in PF and ESIC, submit the certificate for last 03 Years.
- 2.6 The Bidder should have the GST and PAN (Copies of GST Regn. and PAN).
- 2.7 The Firm should have at least one of its own office and service centre functioning in Ranchi City for not less than three years as on the date of commencement of issue of RFP.
- 2.8 The Bidder should provide at least 1 AMC (Annual Maintenance Contract) single work order of a single system for not less than 100 IP cameras for last 2 years from Central/State Government departments, PSU'S, Educational, autonomous bodies during last three years.
- 3.0 Earnest Money Deposit: The tender must be accompanied by earnest money deposit (EMD) in the form of a Demand draft drawn on any Nationalized/ Schedule Bank in favour of Jawahar Vidya Mandir. The earnest money shall be kept deposited up to a period of 06 (six) months beyond the validity of the Tender. The earnest money will not earn any interest. Tenders not accompanied by earnest money shall be rejected. On acceptance of the tender (but not earlier than the expiry date of validity of tender) the earnest money will be returned to the unsuccessful tenderers on request.
- 4.0 Cost of the Tender: The cost of the tender will be Rs.1000/- (One thousand only) non-refundable in the form of a Demand draft/ AT PAR CHEQUE drawn on any Nationalized/ Schedule Bank in favour of Jawahar Vidya Mandir.

IF A FIRM FILING TENDER DOES NOT FULFILS ALL OR ANY OF THE ABOVE ELIGIBILITY CRITERIA MENTIONED ABOVE, THE TENDER OF THE FIRM WILL NOT BE CONSIDERED.

- 5.0 Scope of work: The scope work shall include but not limited to supply and installation of the equipment/ Software as per Technical Specification enclosed at Annexure-I, on FOR, JVM, Ranchi.
- 5.1 The scope of work shall include supply ,installation, testing and commissioning of the CCTV's/ Servers/ TV/ Desktop PC/ Associated cabling in class rooms, corridors ,playgrounds ,parking's of the school campus complete in all respect to be operative and for Jawahar Vidya Mandir, Ranchi . The POE switches shall be installed at suitable locations to be finalised during Detailed Engg. Stage and Servers along with Desktop Station at IT Centre.
- 5.2 The Entire Control of the CCTV shall be provided from two locations.

Any other material required for the system to make it operational is also under the scope of the Tenderer.

- 5.4 230 V + 10 %, 50 Hz + 5% shall be made available for UPS input at ground floor in each Pre Primary ,Primary Block, Secondary block and Senior Secondary Block from Employer's board. Further power distribution from this Employer's to network switches etc system including complete cabling work, Distribution boards and required electrical accessories with suitable protection devices shall be in scope of Tenderer.
- 5.5 Training to the 5 nominated staffs of Jawahar Vidya Mandir shall be provided for minimum of 3 days.

6.0 SUBMITTALS:

- 6.1 Drawings: The system Tenderer shall submit all drawings, datasheets, catalogues, and bill of materials for approval/reference.
- 6.2 Drawings shall be submitted in standard sizes as indicated in CCTV layout drawing (A4 size).

 - c) Cable connectivity drawings and cable schedule. (A4 Size)

7.0 SYSTEM DOCUMENTATION

- b) Manufacturer's instructions and drawings for installation, maintenance, and operation of all purchased items.

- f) Quality Assurance Plan Operation and maintenance manuals.
- 8.0 Price: The Tenderer shall quote for the items indicated above on FOR JVM, Shyamali, Ranchi basis. The quoted price shall be firm and binding and shall not be subject to any variation whatsoever on any account till completion of supply. All applicable taxes & duties shall be indicated separately. (Un-priced copy of Price Bid indicating "quoted" against each item should be submitted along with Techno-commercial bid).
- **9.0 Taxes & Duties**: Except as otherwise specifically provided in the order, the CONTRACTOR shall bear and pay all taxes, duties, levies as charges for the subject work.
- **10.0 Validity of Rates**: The rate quoted by the tenderer shall remain valid for a period of 90 (ninety) days from the date of opening of quotation.

11.0 Time Schedule:

- 11.1 The successful tenderer shall be required to complete the supply & installation of above item within two months from the date of receipt of order.
- 11.2 In the event the supplied material is not conforming to the ordering specification and approved make/brand, the material so supplied will be rejected without paying any price/compensation. The decision of JVM in this regard will be final.

12.0 Payment Terms:

- 12.1 No advance payment shall be made. The bank guarantee for 10% of total contract price towards performance guarantee to be kept valid till completion of three years warranty period and is to be submitted within one week from award of work order.
- 12.2 Subject to the deduction which JVM Shyamali may be authorized to make under the contract, The payment shall be released within 15 (fifteen) days of on submission of bill along with receipted challan, Inspection & Acceptance Certificate to be issued by JVM as per following schedule
 - a) 30% payment of total order value shall be released within 15 (Fifteen) days of supply of materials on submission of Bill alongwith PO Copy, receipted challan & acceptance certificate to be issued by JVM, Shyamali
 - b) 60% payment of total order value shall be released within 15 (Fifteen) days of complete erection, testing and commissioning of the complete system.
 - c) 10% payment of total order value shall be released within 45 (forty five) days of complete erection, testing and commissioning of the complete system.

13.0 Warranty:

- 13.1 The Tenderer shall provide comprehensive onsite warranty for all goods/equipment supplied for period of 3 (three) years from the date of final acceptance of the system. The maintenance services, including spares shall be free of cost during the warranty/guarantee period
- 13.2 All the works including power distribution boards, cameras, Servers, POE switches, Hard disks, cables. and overall workmanship of the CCTV systems must be warranted against any

- manufacturing/design/installation defects for a minimum period of 3 years from the date of hand over of the system to the officials of Jawahar Vidya Mandir
- 13.3 The warranty shall cover faulty design, improper material, manufacturing defects and unsatisfactory performance of system. In case the equipment fails to function inspite of necessary repairing work during the warranty period, the defective equipment shall be replaced with a new one free of cost.
- **14.0 Inspection:** The inspection of materials shall be carried out by JVM after receipt of materials at destination.
- 15.0 LIQUIDATED DAMAGES: Time and date stipulated in the Contract for completion of delivery and installation of CCTV System shall be deemed to be the important activity of the Contract. If, however, the Tenderer fails to fulfill the delivery and installation within the time schedule, or within such extended time schedule as may be further granted, the Tenderer shall be liable to pay as Liquidated Damages (LD) and by way of penalty a sum of 0.5% of the contract price per week of delay or part thereof, and such liquidated damages shall be limited to a maximum ceiling of 5% of the Contract Price. In case the reasons for delay in supply & installation of CCTV System are not attributable to the Tenderer, then the LD clause shall not be applicable for such delay.
- **16.0** Acceptance of Order: JVM is not bound to accept lowest or any Tender or to assign reasons whatsoever for non-acceptance. JVM also reserves the right to cancel the tender without assigning any reason whatsoever.
- **17.0 Evaluation of Tender:** Tenderer should quote for all the items as per enclosed price bid format (Annexure-IV). Part offer or incomplete offer shall be liable to be rejected. Price of the techno-commercially eligible tenderer shall be evaluated on overall basis.
- 18.0 NO CLAIM OR COMPENSATION FOR SUBMISSION OF TENDER: The Tenderer whose Tender is not accepted shall not be entitled to claim any costs, charges, expenses of and incidental to or incurred by him through or in connection with his submission of Tender, even though JVM may elect to withdraw the Invitation of Tender
- **19.0 TRANSIT INSURANCE:** Tenderer shall arrange transit insurance on his own and at his own cost for transportation of equipment to JVM, Ranchi.

20.0 NEGLIGENCE, DEFAULT AND RISK PURCHASE

- 20.1 If the Tenderer fails to execute the work with due diligence or expedition or shall refuse or neglect to comply with any order given to him in writing by JVM in Contract, JVM may give notice in writing to the Tenderer calling upon him to make good the failure, neglect or contravention within such time as may be deemed reasonable and in default of the compliance with the said notice, JVM without prejudice to its rights under the Contract, may rescind or cancel the Contract holding the Tenderer liable for the damages that JVM may sustain in this regard.
- 20.2 Should the Tenderer fail to comply with such notice within a reasonable period from the date of serving thereof, JVM shall have the option and shall be at liberty to take the work wholly or in part out of the Tenderer's scope and may get the same executed by alternate

agency at Tenderer 's risk and cost. This shall be without prejudice to JVM's rights under other clauses of this Contract.

21.0 SUSPENSION AND TERMINATION

- 21.1 JVM may at any time temporarily stop the work under the Contract or any part thereof by serving notice in writing to the Tenderer. Work so suspended shall be resumed by the Tenderer on receipt of instructions from JVM in writing. JVM will not be liable to the Tenderer for any damage or loss caused by such period of suspension of work.
- 21.2 JVM will be at liberty to terminate the Contract without prejudicing its right and affecting the obligations of the Tenderer by giving 15 days' notice in writing in the following events:
 - a) If the Tenderer fails to comply with the provision/provisions of the Contract.
 - b) If the Tenderer is involved in any action involving moral turpitude.
- 22.0 Arbitration:
- 22.1 Any disputes, differences, whatsoever, arising between the parties, the arbitration shall be governed and regulated in all respect according to Laws of India.
- 22.2 The Arbitration proceedings in case of other Indian companies shall be regulated and governed by Indian Arbitration and Conciliation Act 1996, or such modification thereof.
- 22.3 The venue of arbitration proceeding shall be Ranchi.
- 22.4 Work under this Order shall be continued by the Tenderer during the arbitration proceedings, unless otherwise directed in writing by PURCHASER or unless matter is such that the work cannot possibly be continued until the decision of the arbitrator is obtained.
