Sealed quotation are invited from the manufacturer or authorized dealers of Tata Motors at Jharkhand for supply of **one (1) number fully built 56 Seater School Bus Star Ultra of TATA MOTOR** as per technical specification of the bus enclosed as per Annexure-I. Tenderer shall note that the offer shall be submitted as per Technical specification as well as terms & conditions of the tender enquiry. Offer submitted by the tenderer not complying the tender stipulation is liable to be rejected.
- B. The 'Price Bid' shall be submitted in the second envelope which shall be superscribed as **"Price Bid- Do not open"**. The price bid shall be submitted in the **Price Format** enclosed at Annexure-II
- C. Both bids shall be put in a third envelope which should be superscribed as **"Tender for supply of one (1) number fully built 56 Seater School Bus Star Ultra"** and should reach on or before 12.09.2019 till 12.00 noon.
