Scope of work

- 1. Drilling holes at the external and internal perimeter of the building and injecting vapour toxicants to the holes to arrest the entry of termites to the building. The 12 mm diameter holes shall be drilled at a downward angle of about 45 degree preferably from both sides of the plinth wall at approximately 2 feet interval and emulsion squirerd through these holes to soak the masonry using a hand operated pressure pump. The treated holes shall then be sealed.
- 2. Making holes drilling 6 mm holes at the downward angle of about 45 degree all around wooden frame like door and window injecting oil based chemicals to destroy live insects hiding inside the wooden particles. The treated holes shall then be sealed.
- 3. The entire infested area will be sprayed to prevent re-entry of the termite and to destroy live insects hiding inside the wooden panels as per details given below:
 - a) The complete surface area of the wooden paneling will be sprayed with oil based chemical.
 - b) The entire cement floor will be sprayed with water based chemical.
 - c) The entire wall above the wooden paneling as well as the outer side of the wall be sprayed with water based chemical.
 - d) Chemical should apply: CHLORPYRIPHOS 20% ec. Water based, Oil based chemical -TERMSAL.
- 4. Bidder shall submit their Price bid strictly as per the Price Schedule Format- Annexure I provided along-with this bid document. Price submitted by Bidder in any other format shall render their offer invalid and shall not be considered for evaluation.
- 5. The successful Bidder shall be required to complete the job within one month from the date of receipt of order.
