It could include full information as required in Annexure . Both bids should be put in the third envelope which should be prominently super-scribed as ", Ranchi." and addressed to "The Principal, Jawahar Vidya Mandir, Shyamali colony, Ranchi 834002" on or before 16.08.2023 till 1.00 PM. The tenders will be opened on the same date at 4.00 PM on 16.08.2023
- 1.4 Tenders received after due date and time mentioned above, as well as those received without separate sealed envelopes as specified above will not be accepted.
- 1.5 It may be noted that incomplete in any respect or conditional tender will not be accepted.
- 2.0 Eligibility Criteria
- 2.1 Bidder must be registered with GST and PAN .no.

3.0 Earnest Money Deposit:

- 5.0 PRICE: The Tenderer shall quote for the items indicated above on FOR JVM, Shyamali, Ranchi basis. The quoted price shall be firm and binding and shall not be subject to any variation whatsoever on any account till completion of supply. All applicable taxes & duties shall be indicated separately. (Un-priced copy of Price Bid indicating "quoted" against each item should be submitted along with Techno-commercial bid).
- 6.0 **VALIDITY OF RATES:** The rate quoted by the Tenderer shall remain valid for a period of 60 working days from the date of opening of quotation.
- 7.0 TIME SCHEDULE:
- The successful Tenderer shall be required to complete the job within 60 working days from 8.0 the date of receipt of order.
- In the event the supplied material is not conforming to the ordering specification and 9.0 approved make/brand, the material so supplied will be rejected without paying any price/ compensation. The decision of JVM in this regard will be final.
- **PAYMENT TERMS:** 10.0
- The payment shall be released within 15 (fifteen) days of on submission of bill along with 10.1 receipted challan, Inspection & Acceptance on ertified by Supervisor / Engineer incharge of JVM Shyamali.
- INSPECTION: The inspection of materials shall be carried out by JVM after receipt of 11.0 materials at destination.
- ACCEPTANCE OF ORDER: JVM is not bound to accept lowest or any Tender or to assign 12.0 reasons whatsoever for non-acceptance. JVM also reserves the right to cancel the tender without assigning any reason whatsoever.
- EVALUATION OF TENDER: Tenderer should quote for all the items as per enclosed price 13.0 bid format (Annexure-I). Part offer or incomplete offer shall be liable to be rejected. Price of the techno-commercially eligible tenderer shall be evaluated on overall basis.
- SUSPENSION AND TERMINATION 14.0
- JVM may at any time temporarily stop the work under the Contract or any part thereof by serving notice in writing to the Tenderer . Work so suspended shall be resumed by the Tenderer on receipt of instructions from JVM in writing. JVM will not be liable to the 14.1 Tenderer for any damage or loss caused by such period of suspension of work.
- JVM will be at liberty to terminate the Contract without prejudicing its right and affecting the obligations of the Tenderer by giving 15 days' notice in writing in the following events: 14.2
 - a) If the Tenderer fails to comply with the provision/provisions of the Contract.
 - b) If the Tenderer is involved in any action involving moral turpitude.
 - c) The venue of arbitration proceeding shall be Ranchi.
